Multidimensional Education Programme

The Klipheuwel Wind Farm's Multidimensional Education Programme supports education in communities of the Theewaterskloof Municipality. In addition to supporting schools, Klipheuwel Wind Farm's Bursary Programme, which launched in 2016, has already invested around R2 million, across 23 bursary recipients. The bursaries cover tuition fees, travel and accommodation costs, book allowances and even a stipend.

Jeffreys Bay Wind Farm's Early Childhood Development Programme

This programme equips centres with suitable playground equipment to help create safe and stimulating environments for young children. The ECD programme is being rolled out in three phases, namely infrastructure support, providing education material and capacity building for educators and governing bodies. It provides each ECD centre with a budget of between R7000 and R20000, depending on the equipment supplied and whether structural repairs are required to existing equipment.

Healthy Mom and Baby Clinic's Mobile Clinic

This is a mobile outreach programme that focuses on impoverished communities in the Ebumnyameni, Donkerhoek and Ocean View communities. The mobile clinic supports children with malnourishment and developmental defects caused by various nutritional shortages. This mobile clinic is about taking the service to the community, with a focus on 'Mom and Baby', prioritising the first 1 000 days of a baby's life.
